

## A Joint Admissions Agreement

### Between Brookdale Community College and LIM College

The purpose of this Joint Admissions Agreement (“Agreement”) is to outline the procedure for a Joint Admissions Program between Brookdale Community College (hereinafter identified as Brookdale) and LIM College (hereinafter identified as LIM).

The Joint Admissions Program stipulates that upon admission to Brookdale in the Associate of Science degree in Fashion Design and Merchandising, students are guaranteed admission into LIM College, provided they later complete their degree program with a minimum cumulative grade point average of 2.0 and by the time of completion of the Brookdale degree program, have met all other requirements as outlined elsewhere in this Agreement and any other applicable standards for LIM admission. Further, such admission may be withheld by LIM for any student that has been found to have committed any offense which led to discipline at Brookdale or otherwise violated Brookdale’s codes of conduct (including any of Brookdale’s “Core Values and Behavioral Expectations”), student handbooks, or any other applicable behavioral standard, in any way. The determination to withhold admission to a student on the foregoing basis will be made after consultation between both parties but will be made solely by LIM at LIM’s sole discretion. Students will be guaranteed admission into the following LIM College majors:

**Brookdale Program:** Fashion Design and Merchandising, Design Track  
**Degree:** Associate of Science, (A.S.)  
**LIM Program:** Business of Fashion  
**Degree:** Bachelor of Business Administration, (B.B.A.)

**Brookdale Program:** Fashion Design and Merchandising, Merchandising Track  
**Degree:** Associate of Science, (A.S.)  
**LIM Programs:** Fashion Merchandising, Visual Studies, Marketing, and Management  
**Degree:** Bachelor of Business Administration, (B.B.A.)

Students must declare and be accepted directly into the major as first-time matriculated freshmen or transfer students at Brookdale. Students should plan to complete their baccalaureate degree at LIM in four additional semesters (or the equivalent for part-time students) in one of the programs listed in the LIM and Brookdale Articulation Agreement. Completion of degree requirements within four semesters is also dependent upon the student’s program of study and progress in completing the requirements of the major.

To be eligible for the Joint Admissions Program, students must complete the Joint Application form provided by Brookdale. In addition, in the students’ final semester at Brookdale the student must complete the LIM College/Brookdale Community College VIP application.

The Joint Admissions Program is open to:

1. Applicants to Brookdale who will be first-time, matriculated freshmen; or
2. Transfer applicants to Brookdale who will enter with fewer than 24 credits of completed college work, except students who were previously matriculated at LIM or otherwise noted; or
3. Any current matriculated Brookdale student who applies to the Joint Admissions Program prior to the completion of 24 credits of college work, except where otherwise noted.

LIM and Brookdale agree jointly to provide the following:

1. Each institution will designate a coordinator and an academic advisor for the Joint Admissions Program.

LIM agrees to provide the following for associate degree candidates at Brookdale who apply for Joint Admissions:

1. LIM representatives will meet at Brookdale with students in the Joint Admissions Program. The purpose of these meetings will be to provide academic advice about LIM's curriculum and general information about LIM.
2. LIM agrees to provide, as needed, information sessions with faculty and staff of Brookdale who will be involved in consulting and advising students enrolled in the Joint Admissions program.
3. An Articulation Agreement outlined as a viewable chart of course equivalencies between programs will be made available on the LIM College website for students to plan out their course of study. The Articulation Agreement will be updated as new courses present themselves in the curriculum or as syllabi change.
4. Associate degree candidates will be invited to participate in at least one LIM campus or community event each semester until their enrollment at LIM.
5. Joint Admissions students will be eligible for partnership scholarships on the same basis as other LIM applicants/students. *See Appendix A.*

### SCHOLARSHIPS

LIM College in partnership with Brookdale Community College, will create and award the LIM College/Brookdale Community College Transfer Scholarship, in an effort to encourage Brookdale Community College students to earn their associate degree credentials, facilitate transfer to the four-year institution, and support completion of the bachelor's degree at LIM College. These scholarships will also serve as marketing/recruitment tools for the receiving institution.

The LIM College/Brookdale Community College Scholarships will have the following criteria:

1. Students must graduate from Brookdale Community College with a minimum GPA of 2.0
2. Students MUST graduate with an associate's degree from Brookdale Community College
3. Students must register at the receiving institution as full-time, matriculated students
4. The scholarships will be renewable, as long students meet the following minimum requirements:
  - a. Maintain a cumulative GPA of 2.0
  - b. Maintain full-time matriculated status
  - c. Maintain satisfactory academic progress towards a degree at the receiving institution

Brookdale agrees to provide the following for Associate degree candidates at Brookdale who apply for Joint Admissions:

1. Brookdale will provide the necessary applications for students who want to apply for joint admission to Brookdale and LIM. The cost of printing the application will be assumed by Brookdale.

2. Brookdale will be responsible for the selection of candidates to the Joint Admission program. Applications will be evaluated according to the basic criteria in effect at Brookdale.
3. On October 1<sup>st</sup> and February 1<sup>st</sup> of each year, Brookdale will provide LIM with Name, Address, Phone, Email and prior school attended information of all students participating in the Joint Admissions program. Also, at this time, Brookdale will submit a list of the Joint Admissions students scheduled to graduate at the end of the semester who have indicated their intent to attend LIM the following semester, along with copies of their transcripts.
4. Brookdale will provide to LIM, on an ongoing basis, any and all records related to Joint Admissions students, including but not limited to, updated disciplinary records.
5. By July 1 (for fall enrollees) and January 15 (for spring enrollees) Brookdale will send LIM official proof of receipt of Associate's degree for Joint Admissions students and final transcripts.
6. Brookdale will assist in setting up advisement programs involving LIM faculty and staff.

Articulation for Transfer Students Not Participating in Joint Admissions:

Procedures outlined herein relate specifically to students who simultaneously apply to Brookdale and LIM. Some students who apply to Brookdale have not decided upon their ultimate educational objective or transfer destination. During the course of study at Brookdale, they may decide upon transferring to LIM.

The two institutions agree to make every effort to facilitate transfer to LIM of Brookdale graduates and pending graduates not covered by this agreement by making available to them the same academic advisement and consultation made available to Joint Admissions students. It is understood, however, that students not covered by the Joint Admissions agreement must apply and meet all admissions standards applicable to any applicant at LIM.

Terms of This Agreement

This Agreement is effective as of September 1, 2020. The Agreement will remain in effect for four years. All students who apply through the Fall of 2024 to Brookdale will be eligible for Joint Admissions. LIM and Brookdale agree to assess the Joint Admissions Program in four years with the intent of extending the agreement, making adjustments as necessary, expanding its scope to encompass other programs at Brookdale and at LIM, as appropriate.

## LIM College and Brookdale Community College Articulation Agreement

**College of Agreement Initiation:** LIM College

**Brookdale Program:** Fashion Design and Merchandising, Design Track

**Degree:** Associate of Science, (A.S.)

**LIM Program:** Business of Fashion

**Degree:** Bachelor of Business Administration, (B.B.A.)

**Brookdale Program:** Fashion Design and Merchandising, Merchandising Track

**Degree:** Associate of Science, (A.S.)

**LIM Programs:** Fashion Merchandising, Visual Studies, Marketing, and Management

**Degree:** Bachelor of Business Administration, (B.B.A.)

LIM College and Brookdale Community College have entered into this Articulation Agreement for the transfer of credits to benefit those students who wish to pursue a degree at LIM College in the BBA in either the Business of Fashion, Fashion Merchandising, Visual Studies, Marketing, and Management.

### **Articulation Agreement**

LIM College and Brookdale Community College agree to the following:

- LIM College and Brookdale Community College will draft and maintain Transfer Guides, as an addendum to this agreement, which identifies the transferring institution courses which satisfy direct, liberal art, or general/flex elective requirements at LIM College.
- Under this Agreement, students who complete the courses listed on the Transfer Guide and earn their Associate's degree; will receive transfer credits for courses where a passing grade has been earned. These credits will be applied for those courses that are required in the chosen program of study.
- Students must meet the admissions and Bachelor's degree requirements for the academic year in which they are admitted. Please refer to the college catalog for complete admissions and program requirements.
- Students are required to submit an official transcript from Brookdale Community College in order to complete the transfer of applicable credit.
- LIM College and Brookdale Community College shall review and update the Transfer Guide as necessitated by curriculum changes by either party.

### **Confidentiality**

Any information shared between the parties which by their nature should be reasonably understood by the receiving party as confidential or proprietary information, shall remain confidential.

### **Marketing**

LIM College and Brookdale Community College will work together to promote this Agreement to the participants which may include on-site events and distribution of marketing materials. The parties may utilize each other's trademarks in connection with promoting the Agreement, provided the other party pre-approves such use; neither party shall gain any right, title or interest in any name or trademark of the other party.

### **Termination and Modification**

This Agreement is effective September 1, 2020 and shall remain in effect for four years. Thereafter, this Agreement may be extended via a writing signed by both parties sixty (60) days prior to the end of the current term. In addition, either party may terminate this Agreement for any reason, or no reason, by providing thirty (30) days written notice to the other party. Should this Agreement be terminated, students enrolled in the Program will be afforded the opportunity to complete the semester or program.

This Agreement is subject to change or modification by mutual written consent between the parties. Any provisions of this Agreement which remain to be performed or by their nature would be intended to be applicable following the expiration or termination of this Agreement, including the continued matriculation of students that are at the time presently enrolled in Brookdale or LIM under the terms of this Agreement, shall survive the expiration/termination of this Agreement.

### **Independent Contractors**

The parties intend that the relationship established between them pursuant to this Agreement shall be that of independent contractors. No agent, employee or servant of Brookdale shall be deemed to be an employee, agent or servant of LIM. No agent, employee or servant of LIM shall be deemed to be an employee, agent or servant of Brookdale. The manner and means of conducting the work hereunder are under the sole control of each party regarding each party's obligations. None of the benefits provided by LIM to its employees including worker's compensation insurance and unemployment insurance is available from LIM to Brookdale's employees, agents or servants. None of the benefits provided by Brookdale to its employees including worker's compensation insurance and unemployment insurance is available from Brookdale to LIM's employees, agents or servants. Each party will be solely and entirely responsible for its acts and for the acts of its agents, employees, servants and subcontractors during the performance of this Agreement.

### **Additional Provisions**

1. The curriculum outlined in this Agreement will be reviewed annually by the administrative staffs of both LIM College and Brookdale Community College.
2. LIM College and Brookdale Community College agree to exchange data and documents that will contribute to the maintenance of this program and promote effective cooperation between the two institutions. LIM College and Brookdale agree that any exchange by the parties of student record information protected by the Family Education Rights and Privacy Act (FERPA) and implementing regulations (34 CFR Part 99) shall commit the receiving party to limit the use of such information to the purposes for which the disclosure was made and to impose such limits on any re-disclosure. The parties agree to comply with all applicable statutory and regulatory provisions, including, without limitation 34 CFR 99.31, 99.32, 99.33, 99.34, and 99.35.

This Agreement shall be subject to all present and future applicable laws, orders, rules and regulations of the United States of America, the States of New York and Jersey, and any other regulatory body thereof having jurisdiction.

3. **Cybersecurity Insurance.** LIM College agrees to maintain, during the Term of this Agreement and any renewals thereof, Cybersecurity Insurance in the amount of \$3,000,000 and add Brookdale Community College as an "Additional Insured" under its policy or policies of insurance. LIM College will provide a COI evidencing such coverage annually to Brookdale Community College.
4. Each Institution asserts that it has adopted and will communicate to faculty and students' appropriate policies and procedures regarding non-discrimination and harassment and asserts its responsibility to provide a learning and working environment free from unlawful discrimination. All forms of unlawful discrimination based upon race, creed, color, national origin, ancestry, age, gender (including sexual harassment), marital status, familial status, affectional or sexual orientation, atypical hereditary cellular or blood trait, genetic information, liability for service in the US Armed Forces, disability, or any other category protected by applicable local, state, or city law, are prohibited.
5. Brookdale Community College and LIM College each agree, to the extent authorized under the Constitution and the laws of the States of New York and New Jersey, to indemnify and hold the other harmless from any claim, demand, suit, loss or liability which the Indemnified Party may sustain as a result of the Indemnifying Party's breach of its duties under this Agreement; provided, however, neither Party shall have any obligation or liability

to the other Party under this paragraph for claims, demands or causes of action arising out of the intentional or negligent conduct (whether sole, joint, concurring or otherwise) of the Party, its officers, employees, agents, licensees or invitees, or for the intentional or negligent conduct of any person or entity not subject to such Party's supervision or control.

6. Brookdale Community College and LIM College each agree that any dispute between the parties over the obligations or responsibilities under this Agreement shall be resolved through the decision-making and dispute resolution processes agreed upon by parties involved and that use of such processes is a condition precedent to any remedies established by law.
7. The Parties to this Agreement have had full opportunity to participate and have participated in the drafting and revising of the language of this Agreement and nothing in this Agreement shall be construed against the party drafting this Agreement because of having drafted this Agreement or any specific provision hereof.
8. Any and all notices or other communications required or permitted under this Agreement shall be in writing and shall be deemed to have been duly given if: (i) delivered by hand; (ii) sent by overnight courier; (iii) sent by fax or email, subject to confirmation of receipt; or (iv) sent postage prepaid by registered or certified mail, return receipt requested.
9. This Agreement sets forth the entire understanding between the parties and no amendments or modifications shall be made to the Agreement, except in writing signed by both parties.
10. **Counterparts and Signatures.** This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute a single, enforceable instrument. Facsimile, PDF or scanned copies sent by email of this Agreement and any signatures thereon shall be considered for all purposes as original signatures.


